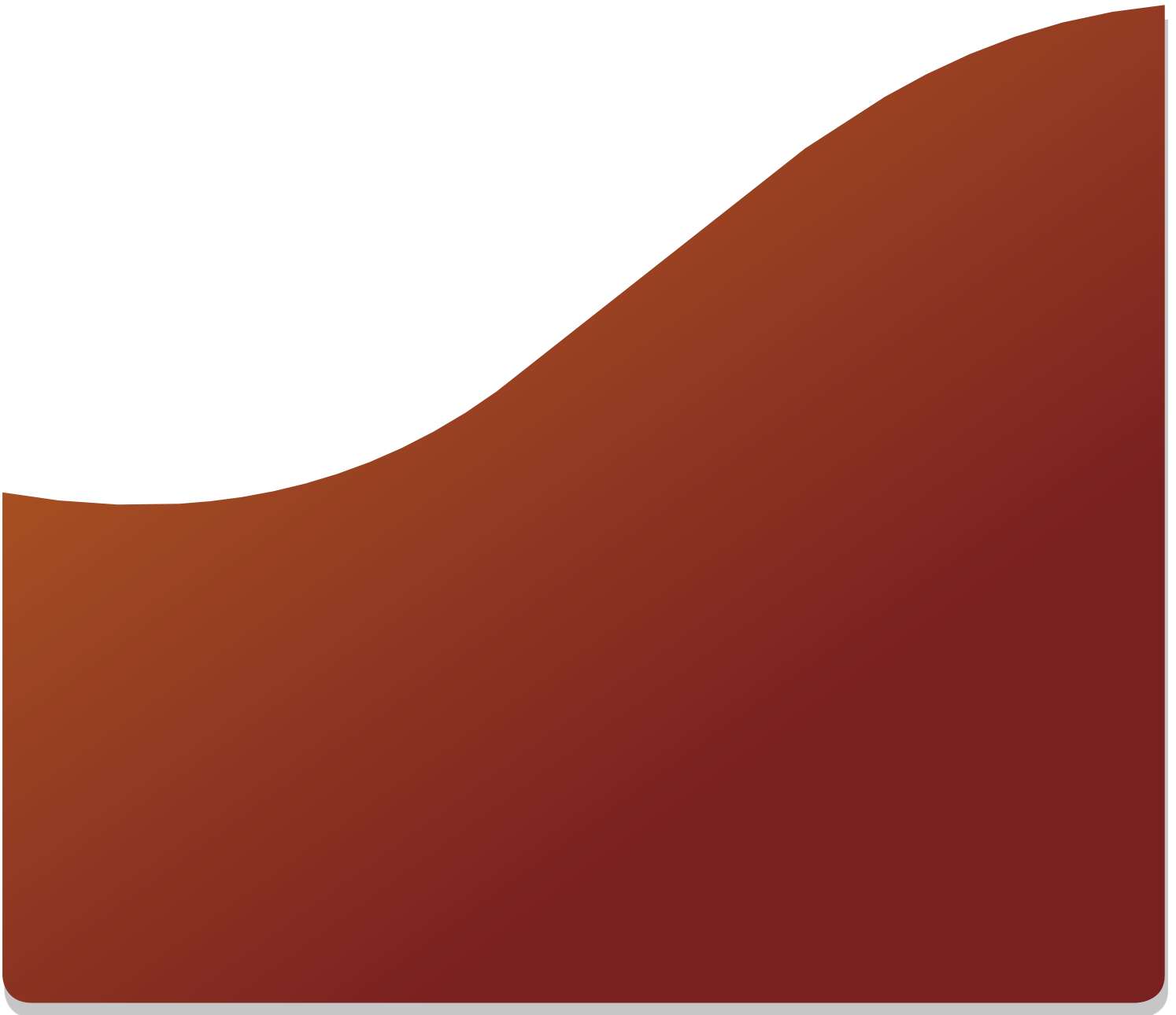

### **8.1 HEARING OF SUBMITTERS ON THE PROPOSED ROAD DISCONTINUANCE OF A SECTION OF RAGLAN STREET, LANCEFIELD**

#### **Summary**

Community consultation has been undertaken under Section 223 of the *Local Government Act 1989* for Council's Public Notice to discontinue part of Raglan Street in Lancefield, as requested by St Mary's Primary School. Following Section 223 of the *Local Government Act 1989* and as part of Council's Community Engagement Policy, those who make submissions can present at a Submitters' Delegated Committee.

The subject part of the road for consideration of future discontinuance is Raglan Street between Chauncey Street and Dunsford Street.

Council received eighty six (86) submissions at the end of the 28-day submission period which commenced on 1 August and closed at 5 pm on 28 August 2023. These submissions are presented as an attachment to this report. Following privacy principles, the submitters' personal details have been redacted.
