

6 DURATION OF MAYORAL TERM

Section 26 of the *Local Government Act* 2020 (the Act) requires a Mayor is to be elected no later than one month after the date of a general election.

Furthermore, Section 26 of the Act requires that before the election of the Mayor a Council must determine by resolution whether the Mayor is to be elected for 1 or 2 years.

Recommendation

That Council resolves to determine that the term of office of the Mayor will be for _____ year term.

7 ELECTION OF MAYOR

Section 25 of the Act requires, at a Council meeting that is open to the public, Councillors to elect a Councillor to be the Mayor of the Council. Any Councillor is eligible for election or re-election to the office of Mayor.

Section 25 of the Act stipulates that the Mayor must be elected by an absolute majority of the Councillors. An absolute majority as defined by section 25(7) of the Act means the number of Councillors which is greater than half the total number of the Councillors of a Council. This means, for Macedon Ranges Shire Council, the Mayor must receive five or more votes to be elected. Governance Rule 10(a) states that "The election of the Mayor must be carried out by a show of hands."

The Chief Executive Officer will call for nominations from Councillors for the position of Mayor.
