## Purpose/Objective

This policy provides a set of guidelines and procedure for keeping children safe while travelling between Kindergartens under the management of Macedon Ranges Shire Council and other education or early childhood services.

## Policy Statement

### Values

Kindergartens under the management of Macedon Ranges Shire Council are committed to:

- the safe arrival of children during travel between Kindergartens under the management of Macedon Ranges Shire Council and [Where we are going]
- ensuring the health, safety and wellbeing of children at all times, conducting risk assessments and ensuring authorisations are obtained from parents/guardians
- providing adequate supervision of all children during the travel between Kindergartens under the management of Macedon Ranges Shire Council and [Where we are going]
- promoting road safety education and safe active travel for children.

### Scope

This policy applies to the approved provider, persons with management or control, nominated supervisor, persons in day-to-day charge, early childhood teachers, educators, staff, students, volunteers, parents/guardians, children, and others attending the programs and activities of Kindergartens under the management of Macedon Ranges Shire Council, including during offsite excursions and activities.

<p>Ensuring the risk assessment considers the following:</p> <ul style="list-style-type: none"> <li>• identify and assess any risks travel between Kindergartens under the management of Macedon Ranges Shire Council and Kindergarten may pose to the safety, health or wellbeing of a child</li> <li>• specify how the identified risks will be managed and minimised</li> <li>• the age, developmental stage and individual needs of the child/ren</li> <li>• the role and responsibilities of the nominated supervisor, staff member, child’s parent, and authorised nominee named in the child’s enrolment record</li> <li>• the role and responsibilities of the Kindergartens under the management of Macedon Ranges Shire Council and Kindergarten or when each individual child is entering or leaving the service premises</li> <li>• the communication arrangement between Kindergartens under the management of Macedon Ranges Shire Council Kindergarten the child is entering.</li> <li>• the procedure to follow when Kindergartens under the management of Macedon Ranges Shire Council has identified the child is missing or cannot be accounted for during the child's travel</li> <li>• given the risk posed by the child's travel, the number of educators or other responsible adults that are appropriate to provide supervision</li> <li>• the proposed route and destination, including any proximity to harm or hazards</li> <li>• The process for entering and exiting: <ul style="list-style-type: none"> <li>○ the service premises</li> <li>○ the pickup location or arrival location</li> </ul> </li> <li>• the procedure to be followed by Kindergartens under the management of Macedon Ranges Shire Council to ensure the child leaves a service premises in accordance with <i>Regulation 99</i></li> </ul>	R	√	√		√

## Background/Reasons for Policy

The Education and Care Services National Regulations mandate that approved providers establish policies and procedures regarding the safe travel of children who travel between an educational service and any other educational or early childhood service, for example from a kindergarten service to a long day care service.

Ensuring the safety and wellbeing of children in Early Education and Care (ECEC) services is the utmost priority, and approved providers and ECEC services must take necessary steps to safeguard children from potential harm or dangers, especially during their travel to and from the service.

Particular attention should be given to the transportation of children, especially during peak traffic times and high foot traffic periods. Protecting children during their journey between the service and other educational settings can be accomplished by preparing comprehensive policies and procedures, along with an effective implementation process.

## Definitions

Term	Definition
<p><b>Adequate supervision</b></p>	<p>(In relation to this policy) supervision entails all children (individuals and groups) in all areas of the service, being in sight and/or hearing of an educator at all times including during toileting, sleep, rest and transition routines. Services are required to comply with the legislative requirements for educator-to-child ratios at all times. Supervision contributes to protecting children from hazards that may emerge in play, including hazards created by the equipment used.</p> <p>Adequate supervision refers to constant, active and diligent supervision of every child at the service, including during travel from one service to. Adequate supervision requires that educators are always in a position to observe each child, respond to individual needs and immediately intervene if necessary. Variables affecting supervision levels include:</p> <ul style="list-style-type: none"> <li>● number, age and abilities of children</li> <li>● number and positioning of educators</li> <li>● current activity of each child</li> <li>● areas in which the children are engaged in an activity (visibility and accessibility)</li> <li>● developmental profile of each child and of the group of children</li> <li>● experience, knowledge and skill of each educator</li> <li>● need for educators to move between areas (effective communication strategies).</li> </ul>
<p><b>Attendance Record</b></p>	<p>Kept by the service to record details of each child attending the service including name, time of arrival and departure, signature of person delivering and collecting the child or of the nominated supervisor or educator.</p>

<b>Regular outing</b>	In relation to education and care services) means an excursion such as a walk, drive or trip to/from a location that the service visits regularly as part of its educational program, and where the circumstances covered by the risk assessment are the same on each trip. If an excursion is a regular outing, an authorisation from parents/guardians is only required to be obtained once every 12 months. A new authorisation is required if there is any change to the circumstances of the regular outing
