Submit the completed application to council via email, post or in person ensuring it is received before close of the roll.

Additional notes

Use this form to apply for enrolment on the Council voters' roll if you occupy rateable property in the Council area and pay Council rates directly or as a lease condition. Note that Council may request proof of occupancy and liability for Council rates.

To qualify for the voters' roll as an occupier, you must meet the following requirements:

- be at least 18 years of age on or before election day,
- be liable to pay council rates as an occupier of rateable property in the Council's municipal area, and
- not be enrolled as a resident of the municipality on the State electoral roll.

If you are an Australian and you live within the Council, you may already be enrolled as a resident on the state electoral roll.

You can only enrol once in a municipality, regardless of the number of properties you own or occupy.

No more than 2 owners and 2 occupiers can be enrolled for a single rateable property. Contact the Council for further assistance if there are people already enrolled for the property.

It is important to note that your enrolment is only valid for one term of the Council. If you continue to occupy the property, an application must be made before close of the roll for each general election.

Once you are enrolled, it is compulsory to vote under section 266 of the *Local Government Act 2020*. Failure to vote may result in an infringement fine equal to 0.5 penalty units.

For this application to be effective, it must be received by Council no later than the close of the roll. The date and time of the close of the roll for each election is published on the VEC website www.vec.vic.gov.au

Privacy Statement

Information provided on this form is collated and stored on Council systems, and a copy will be provided to the Victorian Electoral Commission (VEC) for the purpose of compiling municipal voters' rolls used to conduct Council elections. If provided, email and mobile contact information may be utilised regarding this application and for the purpose of delivering notifications and voting reminders for elections for this Council. These contact details will not be provided to any third party.

Voters' rolls are only available for purposes connected with a Council election or to enable the Council to communicate with constituents regarding Council functions or for a public interest purpose approved by the VEC following consultation with the Information Commissioner. Voters' rolls distributed by VEC will not include dates of birth. Failure to provide requested information may mean that a person cannot be enrolled or vote in Council elections. A person may access their personal information, held in the Council's enrolment records, by making a request in writing to the Chief Executive Officer of the Council.
