Conditions of Use

General

- The Hanging Rock Recreation Reserve is self-funded and unfortunately receives no State or Local Government operational funding. It is therefore necessary to charge entry fees which enable the ongoing operation, care and development of Hanging Rock.
- The Annual Pass is for **personal use only**. It is not to be used for commercial purposes. Failure to adhere to this condition will result in the cancellation of your Annual Pass.
- The Annual Pass is not transferable and should only be used by the applicant or persons within the applicant's household.
- Applications will not be considered where conditions of use have previously not been adhered to.
- The access card remains the property of Macedon Ranges Shire Council.
- A limit of 1 access card per applicant applies.
- No refunds will be given for the cancellation of an Annual Pass.
- The Annual Pass is not valid on major event days.

Annual Pass Term and Fees:

- The Annual Pass is valid for the 12 month period from 1 July 2024 to 30 June 2025.
- The Annual Pass fee is payable prior to an Annual Pass being issued.
- Should an application for an Annual Pass be made part way through the year the fee will be charged on a pro-rata basis (see below).
- Should an applicant lose their access card, a fee of \$12 will apply for a replacement access card.

Fees

If the pass is purchased:

prior to 30 Sept 2024:	\$90
• between 1 Oct 2024–31 Dec 2024:	\$67.50
 between 1 Jan 2025–30 Apr 2025: 	\$45
 between 1 May 2025–30 June 2026 (valid for 14 months): 	\$90
